Assistant Manager, K&B Thiara Imt owned Caltex, Mr. Sourav Haldar, Director of S&P Global Market Intelligence, Industry representative and all the faculty members from the department to the meeting of BOS and placed the agenda for deliberation of the members.

In the beginning, the Chairman gave a brief about the course structure and subject formation which is a joint venture of all two campuses.

The chairman briefed and presented the course structure of different subjects for everyone to view and for further discussion in the meeting.

☐ Discussion on 4-Year Honours Degree Program

- Initiation of 4-Year Honours Degree: The board discussed the launch of the 4-year honours degree program starting from the 2024 batch.
- No Exit Option: It was decided that there would be no exit option for students in this program as per AICTE regulation.
- AICTE Compliance: The new program structure adheres to AICTE guidelines.
- Credit Requirements: The minimum credit requirement for the 4-year program was set at 106 credits, although our program credits total approximately 200.

☐ First Semester Curriculum for 2024 Batch

- Sessional Papers and Subjects: The curriculum includes CA (Core Areas) and FC (Fundamental Courses) subjects.
- 3 FC Papers: Three FC papers will be part of the first semester.
- Specialization in Business Analytics: Business Analytics will be offered as a specialization within the program, not as a separate degree.

☐ MOOCs and IFC Requirements

- MOOCs Credits: Students must earn 20 credits through MOOCs over the 4-year program.
- Industry & Foreign Certification (IFC): At least 3 certifications must be earned each semester, totaling a minimum of 20 certificates for the 4-year program.

☐ Third Semester Curriculum

• Non-AICTE Under UEM Kolkata: The third semester will follow the UEM Kolkata guidelines for the 2023-2027 batch.





- MC Major Courses: Major courses will include core subjects and electives.
- Common IVC: Industry & Value Added Courses (IVC) are common across all semesters.

☐ Fifth Semester Curriculum for 2022 Batch

- Non-AICTE Under MAKAUT: The fifth semester will follow MAKAUT guidelines for the 2022 batch.
- Project on Emerging Technology: Students will undertake a project on emerging technologies, worth 1 credit.

- Fourth Year Requirements: Students in the 4-year program must complete 20 credits in the third year.
